Prayer in the petition is to quash FIR No.0018 dated 24.01.2019 registered under Sections 34, 406, 420, 506 of the Indian Penal Code at Police Station Kalayat, District Kaithal and all the consequential proceedings arising therefrom.

Keeping in view the nature of controversy involved, it was considered appropriate to direct the parties to sit with Mediator and try to reconcile their dispute. Accordingly, parties were referred to the Mediator and with the sincere efforts of the Mediator of Mediation and Conciliation Centre of this Court, parties have arrived at a settlement.
