This is application under Section 482 Cr.P.C. to place on record the Rapat No.047 dated 01.12.2018 vide which offence under Sections 465, 467, 468 & 471 IPC have been added in the present FIR, with further prayer to add the said offences in the head note and prayer clause of the petition.

Vide order dated 17.01.2019 notice of the application was issued to opposite counsel.

Counsel appearing on behalf of respondent No.1-State and respondent No.2, accept notice of the application. They have no objection if the application is allowed.

For reasons mentioned in the application and in view of no objection from the opposite counsel, the application is allowed as prayed for. Rapat No.047 dated 01.12.2018 (Annexure P- 8) is taken on record. Office to add the aforesaid Sections in the headnote and prayer clause of the petition accordingly.

The present petition has been filed by the petitioner under Section 438 Cr.P.C. for grant of anticipatory bail in case FIR No.0121 dated 01.10.2018 registered under Sections 406, 420 & 120-B IPC (Sections 465, 467, 468 & 471 IPC, added later on vide rapat No.047 dated 01.12.2018) at Police Station Jalalabad, District Fazilka.

Counsel for the petitioner submits that pursuant to the interim direction granted vide order dated 25.10.2018, the present petitioner has joined the investigation.

Learned counsel appearing for the State, on instructions from ASI Gurjant Singh, has not disputed the fact regarding petitioner's joining the investigation.

In view of the above, the interim order dated 25.10.2018 is made absolute, qua newly added sections as well.
