Learned Additional Solicitor General of India points out that during pendency of the writ petition, a decision has been taken, whereby the age of superannuation has been enhanced from 57 years to 60 years across board to all officers/ranks serving in Central Armed Police Forces. A copy of the order dated 19.08.2019, handed over in course of hearing reflects the same position. The same is taken on record.

2. In view of the statement of learned Senior counsel, writ petitions are rendered infructuous.

3. Petitioners shall be at liberty to file appropriate representation for the period they were out of service to seek salary/emoluments.

4. Prima facie, I am of the view that the petitioners cannot

be penalized for no fault of theirs for the period they were out of service and it would be appreciated if respondents take a sympathetic view and accord them the benefit of salary for the said period. They were all throughout available for work but were not allowed despite their case being squarely covered by Division Bench judgment of Delhi High Court that was upheld by Hon'ble the Apex Court.

5. Disposed of accordingly.

7. Pending application, if any, shall also stand disposed of.
