AVNEESH JHINGAN, J (Oral):

These contempt petitions have been filed pleading wilful
disobedience of order dated 16.08.2013 passed by this Court in
CWP No.17766 of 2013.

Learned counsel for respondent No.1 submits that
directions dated 16.08.2013 of this Court have been complied with
as claim of the petitioners with regard to solatium and interest was
determined and accepted. He further submits that due payments
have been forwarded to the competent authority for disbursal. He
undertakes that details of the amounts found due would be provided
to the petitioners within three weeks from today. He has forwarded
copies of letters to the learned State counsel vide which amounts
have been forwarded to the competent authority.

Learned State counsel submits that she is not in a position either to admit or to deny the said position. However, in case any amount is received, same would be disbursed within three months. She submits that in case amount has not been received, the said fact would be communicated to the respondent No.1 within two weeks from today.

Learned counsel for respondent No.1 ensures that if such occasion arise, amounts would be forwarded within one week to the competent authority.

In view of above, the contempt petitions are disposed of.

Petitioners shall be at liberty to avail remedies in accordance with law in case grievance still survives.

In case statements made today in the Court are not adhered to, petitioners shall be at liberty to revive the contempt petitions.
