The petitioner seeks grant of regular bail in case FIR No.263, dated 21.8.2017, registered under Sections 302, 34 of the IPC, Section 25 of the Arms Act and Section 3(2)(V) of the Scheduled Castes and the Scheduled Tribes (Prevention of Atrocities) Act, 1989, at Police Station City Rewari.

Counsel for the petitioner has argued that the petitioner has been in custody for more than one and half years and the father of the deceased, the alleged eye witness, has turned hostile.

Learned AAG Haryana, on instructions from ASI Veer Singh, states that the trial is at the fag end; only two government witnesses remain to be examined; the case is now fixed for 9.4.2019, and the prosecution will

present the said two witnesses for giving their evidence on that date.

In these circumstances, this petition is dismissed. It is directed that in case the said two witnesses are not available to give their testimony on the said date, the trial Court shall release the petitioner on bail to its satisfaction. It is, however, made clear that pursuant to this order, bail is granted to the petitioner and he does not file bail bonds, he would not be entitled to count any future period of custody in the present case.

Since the main case has been decided, the pending C.Ms, if any, also stand disposed of.
