**HARI PAL VERMA, J.(Oral)**

Prayer in this petition filed under Section 482 Cr.P.C. is for quashing of DDR No.34 dated 28.08.2015, Police Station Naya Gaon, District SAS Nagar in cross version F.I.R. No.70 dated 27.08.2015 registered under Sections 323, 341, 342, 294, 354-A, 506, 34 of IPC at Police Station Naya Gaon, District SAS Nagar (Annexure P-1) and all subsequent proceedings arising therefrom on the basis of compromise dated 23.05.2019 (Annexure P-2).

This Court vide order dated 31.05.2019 had directed the parties to appear before the Illaqa Magistrate/trial Court to get their statements recorded and the learned Magistrate was directed to send its report qua the genuineness of the compromise.

Pursuant to the aforesaid order, parties have appeared before learned Judicial Magistrate Ist Class, Kharar and got their statements recorded. On the basis of the statements so recorded, learned Magistrate has submitted report dated 22.07.2019 to the effect that the compromise is genuine and has been effected between the parties voluntarily and with their free will.

Respondent No.2-complainant, namely, Balbir Singh has made his statement with regard to compromise before learned Magistrate on 04.07.2019. The same is reproduced as under:-

*“Stated that I have compromised the matter with the accused. Copy of compromise is Ex.C1. I identify my signatures on this compromise. This compromise has been executed with my own accord and free will and without any undue influence or pressure from any quarter. I have no objection if the present FIR be quashed.”*

Learned State counsel as well as counsel for respondent No.2 have not disputed the factum of compromise between the parties.

In view of the above, no useful purpose would be served to continue with the proceedings before the trial Court in the instant case.

Following the principles laid down by the Full Bench judgment of this Court in ***Kulwinder Singh and others Versus State of Punjab and another 2007 (3) RCR (Criminal) 1052*** and approved by the Hon'ble Supreme Court in ***Gian Singh Versus State of Punjab and others (2012) 10 SCC 303***, this petition is allowed and DDR No.34 dated 28.08.2015, Police Station Naya Gaon, District SAS Nagar in cross version F.I.R. No.70 dated 27.08.2015 registered under Sections 323, 341, 342, 294, 354-A, 506,

34 of IPC at Police Station Naya Gaon, District SAS Nagar (Annexure P-1)  
and all subsequent proceedings arising therefrom are quashed qua the  
petitioners on the basis of compromise dated 23.05.2019 (Annexure P-2).
