Present petition has been filed under Section 482 Cr.P.C. for quashing/modifying the impugned order dated 06.05.2019 (P-3), passed by learned Additional Sessions Judge, Kapurthala, vide which, while suspending the sentence of the petitioner, imposed by learned trial Court, he was directed to deposit 25% of the total compensation amount as awarded by learned trial Court.

After arguing for sometime, learned Counsel for the petitioner wishes to withdraw the present petition.

Dismissed as withdrawn.

However, keeping in view the provisions of Section 148 (2) of the Negotiable Instruments (Amendment) Act, 2018, which has come into force on 01.09.2018, the period for deposit of 25% of the compensation amount be treated as 60 days instead of 30 days in terms of order dated 06.05.2019.
