ARUN MONGA, J (ORAL)

After arguing at length, learned counsels are *ad idem* that in the interest of justice and equity, it would be appropriate that the entire voter list be re-drawn by extending the cut off date of payment of annual dues qua all categories of Members i.e. Patron Members, Life Members and Annual Members (old and new Members).

CWP-14647-2014 and other connected matter

2. After deliberations, learned counsels suggest that let the cut off date qua determining the right of franchise be extended to 31.07.2012.

3. Ordered accordingly.

4. It is, however, made clear that some of the abovesaid Members had deposited their dues in the account of *Sabha* but the amounts were refunded on or before 31.07.2012. The said Members shall also be allowed to exercise their right of franchise, as per the voter list.

5. In view of the aforesaid, the writ petitions are disposed of and the impugned orders dated 21.05.2013 (Annexure P-9), 29.10.2013 (Annexure P-10) and 18.03.2014 (Annexure P-11) are set aside. Accordingly, a direction is issued to Respondent-Deputy Commissioner, Fatehabad to make a fresh voter list and all concerned shall be at liberty to make their representations before the Deputy Commissioner. The objections so received by the Deputy Commissioner shall be dealt with in accordance with law.
