GURVINDER SINGH GILL, J. (ORAL)

1. The petitioner seeks grant of regular bail in case registered vide FIR No.30 dated 23.1.2019 under Sections 3, 4, 5 and 6 of Pre-conception and Pre-natal Diagnostic Techniques (Prohibition of Sex Selection) Act, 1994 and Sections 420, 201 & 120-B of the Indian Penal Code registered at Police Station Tohana, District Fatehabad.
2. The allegations in nut-shell are that pursuant to receipt of a secret information that a gang was involved in sex determination near Fatehabad, Tohana, a raiding team was constituted. One Jyoti was associated with the team as decoy client who was having pregnancy of 3 ½ months. It is alleged on 22.1.2019 said Jyoti was sent along with Kuldeep and Anjali and who approached Geeta working in a

private hospital and with whom a deal was struck for checking the pregnancy for an amount of ₹25,000/-. Kuldeep was sent along with Jyoti (decoy client) accompanied by Jyoti's grand-mother, mother-in-law, Ompati to meet Geeta. Geeta sat in the car of Kuldeep and asked him to take the car to District Moonak and upon reaching Moonak, Geeta alighted from the car and talked with Satnam Singh telephonically. It is alleged that after 2 hours a white coloured car came there and Geeta & Jyoti sat in the car and went away. After sometime Geeta called Kuldeep asking him to come to bus-stand Moonak and where the team apprehended Geeta on the spot and Jyoti informed the team that an ultra-sound has been conducted and she was informed that she was carrying a boy in her womb. It is further alleged that the team also recovered an amount of ₹11,000/- from Geeta and upon comparing serial numbers they were found to be the same which had been handed over by Civil Surgeon, Fatehabad. It is further case of the prosecution that thereafter Geeta led the team to the place where ultra-sound was conducted and from where they came to know that a lady named Krishna works as a midwife. It was informed that the said Krishna stays there alone and that another woman brings ultra-sound machine on a scooter. However, at that moment no one was present and upon entering the room no incriminating equipment was found from the room.

3. Learned counsel for the petitioner has submitted that he has falsely been implicated in the present case and has been implicated on the

basis of disclosure statement made by co-accused Geetanjali @ Geeta, who has already been granted concession of regular bail by this Court and in any case no ultra-sound equipment was even recovered from the premises where the ultra-sound test is stated to have been conducted.

4. Opposing the petition, learned State counsel has submitted that since the petitioner is specifically named in the FIR and that the petitioner in conspiracy with co-accused had been indulging in racket of illegal sex-determination of foetus, no case for grant of regular bail is made out. It has however been informed that the petitioner has been behind bars since 3.6.2019 and that challan has already been presented.
5. Having considered rival contentions addressed before this Court and while bearing in mind that the petitioner has been behind bars since 3.6.2019 and challan has already been presented, in my opinion, no useful purpose would be served by further detaining the petitioner behind bars as conclusion of trial, in its normal course, is likely to take some time. The petition, as such, is accepted and it is ordered that petitioner be released on bail on his furnishing bail bonds/surety bonds to the satisfaction of learned trial Court/Chief Judicial Magistrate/Duty Magistrate, concerned.
