This petition has been filed by the petitioner under Section 438 Code of Criminal Procedure for grant of anticipatory bail in case FIR No.0049 dated 03.06.2019 under Section 306 of Indian Penal Code, 1860 registered at Police Station Zira, District Ferozepur. The petitioner apprehended his arrest at the hands of Police.

Learned counsel for the petitioner has invited the attention of the Court to the order dated 19.07.2019 whereby while issuing notice of motion to the respondent-State, the interim protection was extended to the petitioner. The said order reads as under:-

“Learned counsel for the petitioner contends that victim Tarsem Singh had litigation with Sardool Singh who was aggrieved against the appointment of Tarsem Singh as Lambardar and had filed an appeal. According to learned counsel, the cause of abetment as described was alleged threats to victim for withdrawing the appeal which is not possible as the appeal was filed by Sardool Singh. He further submits that petitioner has been

indicted only on the ground that he was an acquaintance of Sardool Singh.

Notice of motion for 19.11.2019.

Meanwhile, the petitioner shall join the investigation and would come present as and when called for and in the event of arrest, the petitioner shall be admitted to interim bail on his furnishing personal and surety bonds to the satisfaction of Arresting/Investigating Officer. The petitioner shall also abide by the conditions as specified under Section 438(2) Cr.P.C.”

Learned counsel for the petitioner further contends that in deference to the said order, the petitioner submitted himself before the Police and joined the investigation. According to him, the petitioner cooperated with the Police Authorities during the investigation and furnished requisite bonds to the satisfaction of the Investigating Officer/Arresting Officer.

Learned State counsel who is assisted by HC Jasbir Singh does not dispute this fact that the petitioner has joined the investigation. Learned counsel on instructions from HC Jasbir Singh further states that the petitioner is not required for custodial interrogation for the time being.

Considering above, the petition is allowed and the interim bail granted by this Court vide order dated 19.07.2019 is made absolute.
