**JITENDRA CHAUHAN, J.**

The above noted batch of 38 writ petitions is being disposed of  
by this single judgment as common questions of law and facts are involved  
therein. However, the facts are being derived from CWP No.23869 of 2015,  
for brevity.

Through the instant civil writ petition, the petitioner has sought  
direction to the respondents to consider and appoint him on the post of  
Hindi Master on the basis of higher merit in the physically handicapped  
category on account of declaration of revised result of 'Teachers Eligibility  
Test' vide order dated 05.06.2015 (Annexure P-13).

Learned counsel for the petitioner(s) contends that the case of the petitioner(s) is squarely covered by judgment dated 26.02.2019 passed by this Court in CWP-21108-2017 titled as '**Birinderjit Singh and others Vs. State of Punjab and others**', wherein similarly situated petitioners had approached this Court and a direction was issued to the respondents to constitute a Committee of three officers headed by Chief Secretary and take a decision within a period of two months from the date of passing of the judgment.

Learned State counsel states that she has no objection if the present petitions are disposed of in terms of the aforesaid judgment dated 26.02.2019. Learned State counsel on instructions further submits that the Committee was constituted in the month of May, 2019, however, the Committee has not so far dealt with the issues.

Heard.

Duration of the Committee in issue was two months, however, the same is still subsisting. The Committee so constituted is directed to examine if the case of the petitioners could be treated at par with the petitioners in CWP-21108-2017. If on examination of the case of the petitioners is found to be at par with the petitioners in the aforementioned writ petition, the petitioners be treated in the same manner.

Disposed of, accordingly.
