**By this order, this Court shall propose to dispose of two writ
petitions i.e. CWP No. 26874 of 2015 titled as Nachhattar Singh and others
vs. The Special Secretary, Cooperation, Punjab, Chandigarh and others and
CWP No. 4010 of 2016 titled as Gurmail Singh and others vs. The Special**

Secretary, Cooperation, Punjab, Chandigarh and others.

On considering the submissions made by the counsel for the parties and keeping in view the order dated 14.10.2015 passed by the Special Secretary Cooperation, Punjab, Chandigarh, this Court has decided that the Registrar, Cooperative Societies, Punjab, shall determine the eligible members of the Society as per the records as on 13.02.2013, the date when the Administrator was appointed for the first time in the Society. This exercise be carried out within a period of one month from today. On the basis of the electoral rolls as finalized by the Registrar, Cooperative Societies, Punjab, elections to the Society be held as per the Acts/Rules/Instructions/By-laws within a period of three months thereafter.

With these observations and directions, these writ petitions stand disposed of.
