Present petition has been filed for issuance of direction to the official respondents No.1 to 3 for providing the protection of life and liberty of the petitioner and to take appropriate legal action against the official respondents No.4 to 6 and further prayer is made to decide the representation against respondents No.4 to 6 which is pending before respondent No.2.

This Court has already held in another petition i.e. ***CRM-M-20457-2019; Raj Rani and others vs. State of Punjab and others decided on 06.05.2019*** that unless the statutory proceedings have already been initiated by a statutory authority or Court under Code of Criminal Procedure (for short, 'Cr.P.C'), the petition under Section 482 Cr.P.C is not maintainable for issuance of any direction. The remedy can be a writ petition under Article 226 of the Constitution of India.

In view of the above, the present petition is dismissed.

However, the petitioner shall be at liberty to avail alternate remedy in accordance with law.
