This is an application for disposal of the appeal on the basis of compromise by preponing the date of hearing in an admitted case.

Learned counsel for the claimants has accepted the factum of compromise wherein the Insurance Company has agreed to pay a sum of Rs.30,000/- towards full and final settlement of claim of the claimants inclusive of interest as on date.

Learned counsel for the Insurance Company

undertakes to pay the aforesaid amount within four weeks from today in the executing Court.

Both the parties are *ad idem* that this appeal be decided in terms of aforesaid consensus arrived at between the parties.

For the reasons recorded hereinabove, date of hearing of the appeal is preponed and main case is taken up today.

Main case

Both the parties have agreed to settle the amount of compensation. Insurance Company shall pay an amount of Rs.30,000/- over and above the amount granted by the Tribunal inclusive of interest as on date. This amount shall be treated to be full and final settlement of the claim of the claimants. Insurance Company shall deposit the aforesaid amount within four weeks from today, failing which, the Insurance Company shall be held liable for any other amount and interest as may be decided by this Court.
