ANUPINDER SINGH GREWAL, J (ORAL)

The petitioner is seeking anticipatory bail in FIR No. 137 dated 04.06.2019, under Sections 147, 149, 323, 341, 427, 452 and 506 of the Indian Penal Code, 1860, registered at Police Station Loharu, District Bhiwani.

Learned counsel for the petitioner contends that no specific role has been attributed to the petitioner and he is alleged to have participated in the second occurrence. He also contends that only simple injuries are stated to have been caused to the complainant and her son. He further contends that the main accused, namely, Bhim Singh, Vijay Kumar and Rajesh are in custody.

This Court, by the order dated 28.08.2019, had directed the petitioner to appear before the Investigating Officer and join the investigation and in the event of his arrest, he was ordered to be released on ad-interim bail to the satisfaction of the Investigating/Arresting Officer, subject to the conditions envisaged under Section 438(2) Cr.P.C.

Learned State counsel, on instructions from HC Rajinder Kumar, states that the petitioner has joined investigation and is not required for custodial interrogation.

In view of the submissions of learned counsel for the petitioner and the petitioner having joined investigation, the order dated 28.08.2019 granting interim bail to the petitioner is made absolute.

However, the petitioner shall abide by the conditions stipulated under Section 438(2) Cr.P.C. He shall also join investigation as and when called upon to do so.

The petition stands disposed of.
