This writ petition under Articles 226/227 of the Constitution of India has been filed for issuance of direction to respondent No.6 – Block Development and Panchayat Officer, Mamdot, Ferozepur to conclude the enquiry marked to him vide letter dated 29.3.2019 (Annexure P-5) by respondent No.2- Director, Department of Rural Development and Panchayat, Punjab regarding complaint/ application dated 7.3.2019 (Annexure P-4).

Learned counsel for the petitioner states that at this stage, he would be satisfied, if a direction is issued to respondent No.3 - Deputy Commissioner, Ferozepur to consider and decide the legal notice dated 20.4.2019 (Annexure P-6) expeditiously.

In view of the above, without adverting to the merits of the case, the present petition is disposed of with a direction to respondent No.3 - Deputy Commissioner, Ferozepur to consider and decide the legal notice dated 20.4.2019 (Annexure P-6) in accordance with law within six weeks from the date of receipt of the certified copy of the judgment. In case, on consideration, the competent authority reaches to the conclusion that the benefit claimed by the petitioner is admissible to him, in such eventuality, the consequential relief be allowed to him, within a period of six weeks thereafter. However, in case the competent authority feels that the relief claimed by the petitioner is not admissible or made out, in that case, a speaking order be passed in the matter.
