This is an application filed under Order 22 Rule 3 CPC read with
Section 151 CPC for bringing on record the legal representatives of appellant,
namely, Hari Ram, who is stated to have expired on 12.09.2016 leaving behind his
sons whose details are mentioned in para 2 of the application. The same is on the
strength of registered Will dated 14.07.2014 executed in favour of his sons. It has

been averred that there is no other legal heir apart from those mentioned in the application. The application is duly supported by affidavit of Bijender Singh son of deceased appellant.

Accordingly, in view of the averments made in the application, duly supported by the affidavit, the same is allowed and the LRs of deceased appellant are permitted to pursue the present litigation only. It is made clear that the present order will not be liable to be taken into consideration in any other set of proceedings and is without commenting upon the validity/veracity of the Will executed by deceased appellant. Amended memo of parties is taken on record. Office to tag the same at appropriate place.
