This writ petition under Articles 226/227 of the Constitution of India has been filed for the issuance of a writ, in the nature of mandamus directing the respondent-authority to take action on the representation dated 02.07.2019 (Annexure P-2).

Learned counsel for the petitioners states that at this stage, he would be satisfied, if a direction is issued to respondent No.2-Director, Department of Panchayat and Rural Development Punjab to consider and decide the representation dated 02.07.2019 (Annexure P-2) expeditiously.

Heard.

A complete set of paper book has been handed over to Mr. Vikas Mohan Gupta, Addl. A.G., Punjab in the Court today.

In view of the above, without adverting to the merits of the case, the present petition is disposed of with a direction to respondent No.2-Director, Department of Panchayat and Rural Development Punjab to consider and decide the representation dated 02.07.2019 (Annexure P-2) in accordance with law within six weeks from the receipt of the certified copy of the judgment. In case, on consideration, the competent authority reaches to the conclusion that the request made by the petitioners is admissible, in such eventuality, the consequential relief be allowed to them, within a period of six weeks thereafter. However, in case the competent authority feels that the request made by the petitioners is not admissible, in that case, a speaking order be passed in the matter.
