**ANIL KSHETARPAL, J(Oral)**

Petitioner prays for bail pending trial in a criminal case arising out of FIR No.292, dated 22.11.2018, registered under Sections 307/323/325/148/149 IPC, at Police Station City Jagraon, District Ludhiana.

Gist of the case of the prosecution as noticed by learned Court of Sessions, is extracted as under:-

*“The present case was registered on the basis of statement of complainant Dev Raj son of sant Ram resident of Chungi No.5, Jagraon, P.S.City Jagraon, District Ludhiana, wherein he stated that he is resident of abvoe said address and he used to do the work of Chaudhary at Grain Market, Jagraon. On 20.11.2018, at about 08.30 PM, he (complainant Dev Raj) was doing the work of Chaudhary in firm M/s Mittal and Sons, Shop No.75, during which, one youngman aged about 21 years had come to him (complainant Dev Raj) on foot, who had demanded his mobile phone. When he (complainant Dev Raj) had refused to hand over his mobile phone to the said person, then the said person had started to abuse him and he had returned back. After about 10 minutes, the said person had come back to him (complainant Dev Raj) and at that time, the said person was armed with iron pipe and he was accompanied with 9-10 other persons, who was having long beard and mustaches, had raised lalkara that he (complainant Dev Raj) had insulted his friend Pavi by not giving his mobile phone to him. Then, the said*

*person had asked his accomplices namely Gurtej Singh and Gopi to caught hold of him (complainant Dev Raj). On this, said Pavi had given iron rod blow on his (complainant Dev Raj) head with intention to kill him, which had hit in his head. Then, said Gurtej Singh had given iron rod blow on his (complainant Dev Raj's) head with intention to kill him, which had hit on the left side of his head. After then, he (complainant Dev Raj) had raised alarm, resulting of which, Beant Singh son of Kewal Singh resident of Kothe Ath Chak, Jagraon had reached at the spot and he had tried to rescue him (complainant Dev Raj) from the clutches of above said persons. Then, on the signal of above said person, who was having long beard and mustaches, another person namely Bhamipuria had given baseball bat blow on the face of said Beant Singh, due to which the face of said Beant Singh was badly injured. After then, above said other persons had given beatings to him (complainant Dev Raj) with baseball bats, due to which, he (complainant Dev Raj) had raised alarm, resulting of which, his cousin Satnam Singh had reached at the spot, but the above said persons had not stopped, rather they had told that they would kill him (complainant Dev Raj) and the above said persons had continued to give beatings to him (complainant Dev Raj) with baseball bats, resulting of which, he (complainant Dev Raj) became unconscious. After then, Kamaljit Singh had taken him (complainant Dev Raj) and said Beant Singh to Civil Hospital, Jagraon. Action may be taken.”*

It is apparent from the reading of the FIR that petitioner had given blow with iron rod on the head of the injured.

State counsel, on instructions from the Investigating Officer, who is present in Court, has submitted that the petitioner is involved in 2 other criminal cases.

Keeping in view the aforesaid facts, this court is not inclined to grant concession of regular bail.

Dismissed.
