[1] Prayer in the writ petition is for the issuance of a writ of Mandamus for directing the respondents to pay outstanding stipend amount @ ₹9,000/- per month to the petitioners for internship in the final year of MBBS along with interest @ 24% per annum with effect from the date the stipend amount became due till the date of actual payment.

[2] Learned counsel for the petitioners contends that the petitioners were initially admitted in MBBS Course in Gian Sagar Medical College, Banur, Rajpura, District Patiala. However, due to closure of the said college, the petitioners along with other candidates were shifted to Government Medical College, Amritsar affiliated to the Baba Farid University of Health Sciences, Faridkot pursuant to the orders of this Court in CWP No.7647 of 2017 in case titled as '**Raghav Mittal and others** versus **State of Punjab and others**'.

[3] Learned counsel contends that the petitioners are entitled for payment of outstanding stipend @ ₹ 9,000/- per month as per the Medical Council of India Regulations on account of internship in the final year of MBBS Course and that although the petitioners have already completed their MBBS Course, stipend as admissible has not been paid till date, despite the petitioners having served legal notice-cum-representation (Annexure P/4) dated 30.09.2019 on respondent Nos.2 to 4.

[4] Learned counsel further states that respondent No.2 & 3 are the authority competent to take a decision with regard to payment of stipend @ ₹9,000/- per month to the petitioners and that in the circumstances, the petitioners will be satisfied, if the writ petition is disposed of by directing respondent Nos.2 & 3 to consider and decide the legal notice-cum-representation (Annexure P/4) dated 30.09.2019 expeditiously.

[5] Notice of motion to respondent Nos.2 & 3 only.

[6] Mr. Arun Kaundal, learned Deputy Advocate General, Punjab, accepts notice on behalf of respondent Nos.2 & 3 and states that he has no objection to the innocuous prayer of learned counsel for the petitioners for issuance of directions to respondent Nos.2 & 3 to consider and decide the claim made in the legal notice-cum-representation (Annexure P/4) dated 30.09.2019.

[7] I have considered the submissions of learned counsel for the petitioners, as well as the statement of learned Deputy Advocate General, Punjab appearing on behalf of respondent Nos.2 & 3 and in view thereof am of the considered view that the writ petition can be disposed of by directing respondent Nos.2 & 3 to consider and decide the legal notice-cum-

petitioners for payment of outstanding stipend @ ₹9,000/- per month on account of internship in the final year of MBBS Course in accordance with the rules & regulations applicable as expeditiously as possible, preferably within a period of 04 weeks from the date of receipt of certified copy of this order. If on consideration, the petitioners are found entitled for payment of stipend @ ₹9,000/- per month as per rules & regulations applicable then the same shall be released to the petitioners within a period of 04 weeks thereafter, failing which, the same shall be payable along with interest @ 7.5% per annum with effect from the date of entitlement till date of payment.

[8] Writ petition ***disposed of*** in aforementioned terms.
