The present petition has been filed by the petitioner claiming that she should be granted family pension in lieu of the services, which her late husband had rendered with the State of Punjab.

As per the pleadings, husband of the petitioner was appointed as Special Police Officer (SPO) in the year 1992 as SPO No. 346/I and thereafter, he was absorbed as a Constable on 15.04.2010.

Unfortunately, husband of the petitioner died on 02.12.2011. As the absorption of her husband as a Constable was on 15.04.2010, new pension scheme is being made applicable and family pension is being denied to the petitioner. In support of claim of the grant of family pension made in the petition, counsel for the petitioner is relying upon the decision of this Court in ***CWP No. 2371 of 2010***, titled '***Harbans Lal Vs. State of Punjab and others***', decided on 31.08.2010, to contend that the case of the petitioner is covered by the above mentioned decision as the husband of the petitioner was initially appointed as Special Police Officer (SPO) in the year

1992 and was absorbed as a Constable on 15.04.2010. Hence, old pension scheme will govern the case of the husband of the petitioner and, therefore, the petitioner is entitled for grant the family pension as well.

Learned counsel for the petitioner states that for the said claim, the petitioner has submitted a representation (Annexure P-9) on 12.07.2019, which according to the counsel for the petitioner is still pending consideration with the respondents and at this stage, the petitioner will be satisfied, if a direction is issued to the competent authority to decide her representation (Annexure P-9) in a time bound manner.

Keeping in view the request made by counsel for the petitioner, the present writ petition is disposed of with a direction to the competent authority, to whom the representation has been addressed, to decide the same by passing a speaking order in accordance with law, within a period of three months from the date of receipt of certified copy of this order.

While deciding the representation, the respondent-department shall keep in mind the decision, which has been rendered by this Court in ***CWP No. 2371 of 2010***, titled '***Harbans Lal Vs. State of Punjab and others***' ***CWP No. 11802 of 2008***, titled '***Paramjit Kaur Vs. State of Punjab***', and ***CWP No. 16918 of 2015*** titled '***Ranju Vs. State of Punjab and others***'.
