1. The present appeal has been filed under Section 260A of the Income Tax Act, 1961 (in short 'the Act'), against the order dated 8.6.2018, passed by the Income Tax Appellate Tribunal, Delhi Bench-"I-2" Delhi, in stay application No. 435/DEL/2018 (in ITA No. 1084/Del/2016) dated 8.6.2018 for the A.Y. 2007-08.

2. It was not disputed by the learned counsel for the appellant-Revenue that the matter in issue is no longer res integra and stands concluded by the decision of this Court in **ITA No.5 of 2016**, titled as **"Pr. Commissioner of Income Tax, Gurgaon Vs. M/s Carrier Air Conditioning and Refrigeration Ltd."**, decided on 25.04.2016, whereby, identical question as claimed in the present appeal, has been held not to be substantial question of law.

3. For the reasons recorded in the aforementioned appeal, the present appeal is dismissed.
4. Since the main case has been dismissed, the pending CM, if any, also stands disposed of.
