1 Issue notice.

1.1 Mr. Shreyas Edupuganti accepts notice on behalf of the respondent. Learned counsel says that he does not wish to file a reply as he does not oppose the prayer made in the captioned matters for extension of time.

2 The record shows that the sole Arbitrator was appointed by the Supreme Court, vide order dated 21.07.2017, passed in Civil Appeal No.9417/2017. Learned Arbitrator, evidently, entered upon reference on 09.08.2017.
