ORAL ORDER

3 23-06-2020 I.A. No. 1 of 2020 has been filed with a copy of the order of this Court dated 18.02.2020 passed in C.W.J.C. No. 612 of 2020 (*M/s Kidsco Confescctionery Vs. The State of Bihar and Others*).

In the main writ application, the petitioner is seeking direction to the respondent authorities for grant of subsidy under Industrial Policy introduced by the Government of Bihar and the Government of India in 2001. Similar relief was sought by the



petitioner in C.W.J.C. No. 612 of 2020, which has been disposed of with a liberty to file fresh application for grant of subsidy under the said policy before the Director, Industries, Patna, and in case such an application was filed within four weeks from today, the same should be disposed of within three months thereafter.
