2717 of 2016, so far as payment of arrears of salary is
concerned, has been complied with but the opposite parties
failed to adopt corrective measures so far as payment of arrears



of pension is concerned.

Considering the aforesaid, the Vice Chancellor, Kameshwer Singh Darbhanga Sanskrit University, Darbhanga (opposite party no. 3) is directed to take necessary decision in accordance with law with regard to corresponding pensionary benefits of the petitioner, if not already taken, within maximum period of sixty days from the date of receipt/production of a copy of this order.
