The present writ petition has been filed for directing the respondent no. 7 i.e. the District Programme Officer (Establishment)-cum-Chairman, District Primary Teacher & Transfer Committee,



Gaya to transfer the petitioners in terms of Rule 3 read with Rule 5 (kha) of Bihar Nationalized Elementary Teacher Transfer (Disciplinary Action & Promotion) Rules, 2018 on the choice place mentioned in the representation filed by the petitioners herein.

At the outset, the learned counsel for the petitioners seeks a direction upon the respondent no. 7 i.e. the District Programme Officer (Establishment)-cum-Chairman, District Primary Teacher & Transfer Committee, Gaya to dispose off the representation of the petitioners within a stipulated time frame.

Having regard to the limited prayer made by the learned counsel for the petitioners, I deem it fit and proper to dispose off the present petition with liberty to the petitioners to file appropriate representation before the respondent no. 7 i.e. the District Programme Officer (Establishment)-cum-Chairman, District Primary Teacher & Transfer Committee, Gaya, within a period of four weeks from today and in case such a representation is filed, the same shall be disposed off within a period of four weeks of filing of such representation.

The writ petition stands disposed off on the aforesaid terms.
