The only issue involved in the present writ petition is with regard to refund of seat confirmation fee of Rs. 2000/- as well as seat acceptance fee of Rs.1000/- to the petitioner-institutions which was realized towards admission fee by the Nalanda Open University, the Nodal Agency.

Dr. Anand Kumar, learned appearing on behalf of the University, submits that refund of the aforesaid fee to the petitioner-institutions is under process.
