2 15-10-2020 This application has been filed for modification of judgment dated 6.7.2020 passed in CWJC No.23562 of 2019 titled as Md. Ali Afsar Versus the State of Bihar and others.

It is stated that due to inadvertence, in the cause title of the writ petition, the station of Respondents No.2 to 4 have been wrongly been typed as District ‘Gopalganj’ in place of ‘Siwan’ and due to the said mistake, the said error has crept into



the judgement dated 06.07.2020. It is further stated that the petitioner could not appear before the authority concerned on 27th July, 2020 at 10.30 A.M.

Having heard learned counsel for the parties, the modification, as prayed for, is allowed.

Registry to make necessary correction in the cause title of CWJC No.23562 of 2019 titled as Md. Ali Afsar Versus the State of Bihar and others.
