The petitioner prays for release the Hero Honda
Splender Bike bearing Registration No. PB-10 DC-9427, which
has been seized in connection with C2/135 of 2019 for the
offences punishable under Section 30(a) of the Bihar Prohibition
and Excise Act, 2016.

Learned counsel for the petitioner invites our attention
to the order dated 18th January, 2020 passed in CWJC No. 3245
of 2017 titled as Manish Kumar Chaudhary Vs. The State of
Bihar & Ors. and prays for disposal in terms thereof.
