The petitioner prays for release of Honda Unicorn 160 motorcycle bearing Registration No. BR-32V6292, which has been seized in connection with Jaynagar P. S. Case No. 712 of 2018 for the offences punishable under Sections 272, 273, 414/34 of the Indian Penal Code and Section 30(a) of the Bihar Prohibition and Excise Act, 2016.

Learned counsel for the petitioner invites our attention to the order dated 18th January, 2020 passed in CWJC No. 3245 of 2017 titled as Manish Kumar Chaudhary Vs. The State of Bihar &



Ors. and prays for disposal in terms thereof.
