The petitioner prays for release of the vehicle, namely, Bolero Car bearing registration no. BR 50P 0391 seized in connection with Nirmali P.S. Case No. 138 of 2018 for the offences punishable under Section 30(a) of the Bihar Prohibition and Excise Act, 2016.
