The petitioner prays for release of Hero Passion X Pro motorcycle bearing Registration No.BR25B-8810 which has been seized in connection with Barachatti P.S. Case No. 637 of 2018 for the offences punishable under Sections 30(a) of the Bihar Prohibition and Excise Act, 2016.

Learned counsel for the petitioner invites our attention to the order dated 18th January, 2020 passed in CWJC No. 3245 of 2017 titled as Manish Kumar Chaudhary Vs. The State of Bihar &
