The petitioner prays for release of the Mahindra
Scorpio bearing Registration No. BR-30P-0731, seized in
connection with Case No. C2-133/19/383/19 registered for the
offence under Section 37(b) and 30(a) of the Bihar Prohibition
& Excise (Amendment) Act, 2016.

Learned counsel for the petitioner invites our attention
to the order dated 18th January, 2020 passed in CWJC No. 3245
of 2017 titled as Manish Kumar Chaudhary Vs. The State of
Bihar & Ors. and prays for disposal in terms thereof.



As such, as prayed for, on mutually agreed terms, we dispose of the present petition in terms of the order dated 18th January, 2020 passed in CWJC No. 3245 of 2017 titled as Manish Kumar Chaudhary Vs.
