The petitioner prays for release of the Black Coloured Honda Dream Yuga motorcycle bearing Registration No. BR-22AH1497, seized in connection with Bettiah Town P.S. Case No. 234/2019, registered for the offence under Sections 30(a), 37(a)(b)(c) and 56 of the Bihar Prohibition & Excise Act, 2016.

Learned counsel for the petitioner invites our attention to the order dated 18th January, 2020 passed in CWJC No. 3245 of 2017 titled as Manish Kumar Chaudhary Vs. The State of Bihar & Ors. and prays for disposal in terms thereof.
