The petitioner prays for release of the Super Splender
motorcycle bearing Registration No. BR-22AF-5614, seized in
connection with Thakaraha P.S. Case No. 26/2019, registered
for the offence under Section 30(a) of the Bihar Prohibition &
Excise Act, 2016.

Learned counsel for the petitioner invites our attention
