The petitioner prays for release of the vehicle, namely, Alto Car Maruti Szuki bearing registration no. BR 31AG 7175 seized in connection with Jandaha P.S. Case No. 87 of 2019 for the offences punishable under Sections 30(a) and 37(c) of the Bihar Prohibition and Excise Act, 2016.
