The petitioner prays for release of the vehicle namely
New Hero Splendor (+) Motorcycle Glamour bearing chasis no.
MBLHAW087KHE16739, Engine No. HA10AGKHE20171
seized in connection with Patahi P.S. Case No. 184 of 2019 for
the offences punishable under Sections 30(a), 38 and 41 of the
Bihar Prohibition and Excise Act, 2016.

Learned counsel for the petitioner invites our attention
to the order dated 18th January, 2020 passed in CWJC No. 3245
of 2017 titled as Manish Kumar Chaudhary Vs. The State of



Bihar & Ors. and prays for disposal in terms thereof.
