The petitioner prays for release of vehicle (Scooty
Honda Activa 4g) bearing Registration No. BR08J 3519 which
has been seized in connection with Kharagpur P.S. Case No.
287 of 2018, for the offences punishable under Section 30(a) of
the Bihar Prohibition and Excise Act, 2016.

Learned counsel for the petitioner invites our attention
to the order dated 18th January, 2020 passed in CWJC No. 3245
of 2017 titled as Manish Kumar Chaudhary Vs. The State of
Bihar & Ors. and prays for disposal in terms thereof.



As such, as prayed for, on mutually agreed terms, we dispose of the present petition in terms of the order dated 18th January, 2020 passed in CWJC No. 3245 of 2017 titled as Manish Kumar Chaudhary Vs.
