ORAL ORDER

- 3 04-03-2020 Heard the learned counsel for the petitioner and the

learned APP for the State.

This is an application for grant of anticipatory bail in
connection with Complaint Case No. 1030C/2018, registered for
the offence punishable under Sections 323, 341, 447, 498A,
506/34 of the Indian Penal Code and Sections 3/4 of the Dowry
Prohibition Act.

The allegation is regarding the petitioner herein, who is
the husband of the opposite party no. 2, having tortured her on
account of non-fulfillment of the demand for dowry.

It appears that the present case was referred to the Patna



High Court Mediation Centre, Patna, however, the learned Mediator has furnished a report dated 13.12.2019 whereby and whereunder it has been stated that the mediation has failed.

De hors the allegations and counter allegations levelled by the petitioner and the opposite party no. 2 against each other, the learned counsel for the parties agree that the petitioner shall pay a sum of Rs. 5,000/- per month as maintenance to the opposite party no. 2 till any maintenance proceedings are taken to its logical conclusion and in lieu thereof, the opposite party no. 2 shall not oppose the prayer for bail of the petitioner herein.

Having regard to the submissions made by the learned counsel for the petitioner as also the learned counsel for the opposite party no. 2, I deem it fit and proper to dispose of the present petition with an observation that the petitioner shall furnish an undertaking before the court of learned Sub-Divisional Judicial Magistrate, Khagaria in connection with Complaint Case No. 1030C of 2018 that he would pay a sum of Rs. 5,000/- per month as maintenance to the opposite party no. 2 regularly without fail, as aforesaid, as also would pay a cheque of Rs. 5,000/- at the time of approaching the learned court below for the purposes of grant of anticipatory bail whereupon the petitioner shall be admitted to the privilege of anticipatory



bail, subject to such other conditions as may be deemed fit and proper to be imposed by the learned court below.

It is needless to state that the opposite party no. 2 shall furnish her account number before the learned court below in order to facilitate regular payment of the aforesaid amount of maintenance fixed in the present proceedings.

The present petition stands disposed of on the aforesaid terms.
