direction to the Director, Primary Education to consider

to the petitioners as the lapses on the part of the respondents cannot be a ground to deny the benefit of trained pay scale. The order shall be passed within a period of sixty days from the date of receipt/production of a copy of this order.

With the aforesaid direction/observation, the writ petition stands disposed of.
