Learned counsel submits that the petitioners would be approaching respondent nos. 9 & 12 respectively in respect of their claim for grant of Matric trained scale by way of filing a detailed representation.

In view of such limited prayer, the writ petition stands disposed of.

Petitioners will make their representation within two weeks. Thereafter, the concerned District Education Officers (Respondent Nos. 9 and 12) respectively would be obliged to



consider their claim in accordance with law and dispose of the same by a reasoned and speaking order within three months thereafter.
