The petitioner has filed this petition for direction to the respondent authorities to release the vehicle (Hero Delux Motorcycle) bearing Registration No. BR 05L 9610 in favour of the petitioner which has been seized in connection with Turkauliya (Banjariya) P.S. Case No. 452 of 2019 for the offences under Sections 272 & 273/34 of the Indian Penal Code and Section 30(A) of the Bihar Prohibition and Excise Act, 2016.

Learned counsel for the petitioner invites our attention to the order dated 18th January, 2020 passed in CWJC No. 3245 of 2017 titled as Manish Kumar Chaudhary Vs. The State of



Bihar & Ors. and prays for disposal in terms thereof.

As such, as prayed for, on mutually agreed terms, we dispose of the present petition in terms of the order dated 18th January, 2020 passed in CWJC No. 3245 of 2017 titled as Manish Kumar Chaudhary Vs.
