1. Instant MCC has been filed on the ground that in the order passed on

9/10/2020 in WPS No.4012/2020 description of the petitioners has been shown as Guest Lecturer whereas they are working as Guest Teacher with respondent No.5. Accordingly, in the order at para 1, 2 and 7 same may be corrected.

2. Perused the original writ petition.

3. Considering the same, therefore wherever word 'Guest Lecturer' appears in the order passed on 9/10/2020 in WPS No.4012/2020 it be read as 'Guest Teacher' and in para 7 instead of respondent No.5-college it be read as respondent No.5-school. Rest of the order shall remain as it is.
