. It is submitted that validation proceedings in respect of the tribe claims of the petitioners are pending with the scrutiny committee, the same are not decided.

2. Without issuing notices to the petitioners, the respondents have placed petitioners on the supernumerary post. The proposal is submitted for validation to the committee, well within the time as contemplated under circular dated 30.07.2013.

3. As the impugned action is without notice to the petitioners, we quash and set aside the impugned action.

4. In case, respondents want to take action against the petitioners of placing petitioners on supernumerary post or otherwise, then notice

shall be issued to the petitioners giving opportunity to show cause. In that event, petitioners can file reply and bring all the relevant facts to the notice of the respondent-committee.

5. The committee shall decide the validation proceedings expeditiously and preferably within a period of six months.

6. The petitioners shall appear before the committee on 15.07.2020.

7. Writ petitions accordingly are disposed of. No costs.
