3 It appears that the date of awards is 05th January, 2018. The S.L.A.O. has awarded compensation @ ranging between Rs.3000/- and Rs.6000/- per Are, whereas the Civil Court has granted enhanced compensation @ Rs.25000/- per Are.

4 Thus, considering the same, the applicants-original claimants in these civil applications are permitted to withdraw the compensation amount partly with certain conditions. Hence, the following order:-

ORDER

I. The civil applications are partly allowed.

II. The applicants-original claimants are permitted to withdraw the compensation amount to the extent of

50% out of the amount deposited before this Court on furnishing an undertaking and further 25% of the amount out of the amount deposited before this Court on furnishing solvent security/surety to the satisfaction of Registrar (Judicial) of this Court.

III. Civil applications are accordingly disposed of.
