O R D E R

1. The learned Advocate for appellant/acquiring body Mr.Prashant S. Shinde and Mr.G.K.Joshi, Executive Engineer, Latur Minor Irrigation Division, Latur are present. The learned Advocate for respondents/claimants Mr.N.D.Kendre is present. The learned A.G.P. Mr.A.M.Phule is also present.
2. Parties have agreed that compensation awarded by

the reference Court is covered by Government Resolution dated 3<sup>rd</sup> November, 2016 read with subsequent corrigendum dated 23<sup>rd</sup> February, 2017 and 13<sup>th</sup> August, 2018. In view of the same, the Appellant intends to withdraw the Appeal.
