By order dated 11 February 2020 the Member, Industrial Court, Kolhapur was requested to hear the parties and dispose of the Complaints expeditiously, preferably within a period of six months. It appears that the Member, Industrial Court, Kolhapur has requested for extension of six months time for deciding the Complaints vide letter dated 7 December 2021 and 22 April 2022.
