This is an application for relaxation of condition of attending police station imposed vide order dated 17th July, 2019, passed by this Court while granting bail to the applicant.

2 The applicant was directed to attend concerned police station on every Saturday between 10:00 am. to 11:00 a.m., for a period of 12 months, and, thereafter, on the first Saturday of every alternate month, between 10:00 a.m. to 11:00 a.m., till conclusion of the trial.

3 It is submitted that the applicant has complied the condition by attending the police station. The first part of the condition is already fulfilled. Presently, he is required to attend on first Saturday of every alternate month between 10:00 a.m. to 11:00 a.m. While granting bail to the applicant, it was observed that money received from the victims were deposited into the account of the co-accused who were released on bail by the Sessions Court.

4 Learned APP submitted that to keep the check on the applicant, it is necessary to direct him to attend concerned police station.

5 By order dated 17th July, 2019, the applicant was directed to attend police station on every Saturday between 10:00 am. To 11:00 a.m., for a period of 12 months. It is not reported that there is non-compliance of the condition. The period of 12 months is already over and presently he is required to attend the police station on the first Saturday of every alternate month, between 10:00 a.m. to 11:00 a.m. Considering the aforesaid circumstances, the relaxation of condition of attendance can be granted by directing the applicant to attend

the concerned police station once in four month on first Saturday of the month between 10:00 a.m. to 11:00 a.m., till further orders.

5 Hence, I pass the following order:

:: ORDER ::

- (i) Interim Application No.1431 of 2020, is allowed;
- (ii) The condition imposed vide order dated 17th July, 2019, is modified and relaxed to the extent that the applicant shall attend the concerned Police Station once in four months on first Saturday of the month between 10:00 a.m. to 11:00 a.m., till further orders;
- (iii) Interim Application No.1431 of 2020, stands disposed of accordingly.
