Heard Mr.Naidu, learned Counsel for the applicant/plaintiff and Mr.Choudhary, learned Counsel for the defendants.

2. Respondent no.1 Pravinchand Sehgal and respondent no.3 Pooja Sehgal are the original defendants and judgment debtors. There is no further purpose to continue Mr.Gaurav Sehgal as a party to the present application as urged on behalf of learned Counsel Mr.Naidu appearing for the judgment creditor, as an

amount of Rs.10,05,083/- is deposited in this Court in pursuance of the order dated 13 September 2019.

3. The present application is filed praying that the Prothonotary and Senior Master of this Court be directed to make payment to the applicant of an amount of Rs.10,05,083/- lying in the credit of account of Commercial Execution Application no.565 of 2019.

4. After this application was heard for some time, learned Advocate for the defendants-judgment debtors would not have any objection for the amount to be paid in favour of the judgment creditor/plaintiff. Accordingly, with the consent of the judgment debtor, the interim application is allowed in terms of prayer clause (a). The Prothonotary and Senior Master of this Court shall take necessary steps within one week from today.

5. Disposed of in the above terms. No costs.

6. Needless to observe that all the other contentions of the judgment debtor are expressly kept open.
