PRAYER : Writ Petition filed under Article 226 of the Constitution of India praying for issuance of Writ of Habeas Corpus, calling for the entire records relating to the Petitioner's son detention order under Tamil Nadu Act 14 of 1982 vide detention order, dated 16.12.2019 on the file of the second respondent herein made in proceedings Memo C.No.85/G/IS/2019, quash the same as illegal and consequently direct the respondents herein to produce the Petitioner's son namely S.Deepswaroop @ Brill, S/o.Selvaraj, aged 29 years before this Hon'ble High Court and set the petitioner's son at liberty from detention, now the petitioner's son detained at Central Prison, Coimbatore.
